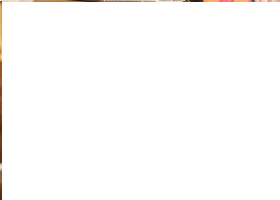

Fair treatment.

- Equal Judiciary & all Justice must be appropriate

1. Proof of Penetration – What it Means

- Even the slightest penetration constitutes the offence:
 - *Erick Onyango Ondeng v Republic (2014) eKLR*
 - *Kisangi v Republic [2023] KEHC 2848; The 160 Girls case and*
- “Many times, the attacker does not fully complete the sexual act during commission of the offence. That is the main reason why the law does not require that evidence of spermatozoa be availed. So long as there is penetration whether only on the surface, the ingredient of the offence is demonstrated, and penetration need not be deep inside the girl’s organ.”
- *Mark Oiruri Mose vs R (2013) eKLR*
